Morashield Plus is a two-component, epoxy based, solvent free osmosis treatment system for GRP boats. The solventless structure makes capillary channel formation in the paint film impossible. Contrast colors (blue & cream) make it easy to apply. As for the best protection please apply 4 coats.

Surface Preparations

Gelcoat should be scraped off. It is leaved to dry after measuring the surface humidity. All surfaces to be coated should be clean, dry and free from contamination. Please contact Moravia office for further information.
